**3.0 Police Report -** The police did not attend and did not send a report. Report of the theft of a car and trailer with bicycles and canoes from Roseberry Court on Stokesley Business Park had been received via Community Messaging.

### 4.0 Matters Arising

4. 1 Defibrillator – The funding for the defibrillator case has been received from NYCC Locality Budget and it has been ordered. Thanks were offered to County Cllr. Heather Moorhouse for her support in our application for this grant. The church electrician has confirmed that the electrics are ready for the arrival of the defibrillator box. This will be installed by the church electrician for insurance purposes. Training on the use of the defibrillator will be available to residents after installation – further details will be placed in the Church magazine and announced in Church. The Parish Council wish to thank the Parochial Church Council for the use of the Church Hall facilities. Thanks also to the Black Swan for the support in the change of location of the defibrillator and for hosting it for so long. A rota of Guardians to check the defibrillator regularly will be drawn up and notices produced to put round the village indicating its location.

R Tomlinson are the key holders and their telephone numbers will be made available for use if the Church Hall is needed as a temporary refuge.
