Parish Council Meeting held in Kirkby Church Hall on 11th December 2017 at 7.30pm

The festive get together for parish residents held prior to the meeting went extremely well and Cllr Frew thanked everyone for their support during the year.

- 1.0 Declaration of Interest None
- 2.0 Minutes of the meeting held on 11th December 2017 agreed and signed by Cllr Frew.
- 3.0 Police Report The Police did not attend but sent a written report.

There were no reported incidents of Anti-Social Behaviour, Auto-Crime, Burglaries, Criminal Damage, Drugs, Violence, Suspicious Activity or Thefts. The police continue to search for suitable venues for marking days to take place throughout the Stokesley area for Dot Peen Marking.

4.0 Matters Arising

- 4.1 Speeding through the village A response has been received from Community Speed Watch. This has been circulated and the PC awaits responses from any volunteers who are willing to take part in this scheme. If there is any positive feedback then the clerk will complete the necessary registration documents.
- 4.2 Dog Fouling The situation has greatly improved throughout the village with no more incidents in the Church Yard. The recently obtained "No Fouling" notices have not been put up but will be if the situation worsens.
- 4.3 Road signs at entrances to village The specs have come back from Cleveland Corrosion Control. "Kirkby" will be in 4inch letters with "in Cleveland" in smaller letters all on a white background. The funding is to come from County Cllr Moorhouse's Locality Budget Funding together with the CIL payment received from HDC.
- 4.4 Kirby Bank TRO The TRO has now been passed, notices are to be produced by Highways which could take up to 3 months. The PC has discovered that funding may be available from NYMNPA for an information board on the Trod; the History Society is to be informed of this possibility.
- 4.5 Settlement Character Assessment ongoing.
- 4.6 Dromonby Bridge Farm see item 5.4
- 4.7 Hill Yard The original footpath diversion is to be closed not the one currently in use. HDC has provided the PC with guidance for street naming and numbering which may be of assistance with this development.
- 4.8 NYCC email on Parish Portal for reporting highway and street lighting matters The clerk is still currently having difficulty accessing this portal. Advice is to be sought from NYCC.
