- **2.0** Police Report Over the last month the following incidents were reported.
  - 2.1 Thefts of approx. 700 and 600 litres of heating oil from Kirkby and Great Broughton School on 2 separate occasions.
  - 2.2 Reports of a suspicious vehicle, a blue Ford Transit van, in the area.
  - 2.3 Burglary, Great Broughton. Padlock damaged and numerous items stolen from a farm outbuilding. Enquiries ongoing.
  - 2.4 Report of a catering van and trailer being broken into. No property taken.
    - 2.5 The police are looking for volunteers to take part in Rural Watch.
    - 2.6 Op Hawk/Op Ferox A reminder to remain vigilant and report any suspicious activity to North Yorkshire Police.
