The Highway Authority recommends that the above application should be **REFUSED** for the following reasons:

- 1. The Planning Authority considers that the roads leading to the site are not of a sufficient width to cater for the traffic which would be likely to be generated by this proposal.
- 2. The existing junction of Hill Road and Kirkby Lane which vehicles would utilise whilst travelling to and from the site is unsatisfactory since the required visibility of 2.4 metres x 43 metres cannot be achieved at the junction in a westerly direction and therefore, in the opinion of the Planning Authority, the intensification of use which would result from the proposed development is unacceptable in terms of highway safety.

The visibility to the west has been assessed as 2.4 metres x 17 metres.
