### **MINUTES**

# **KIRKBY IN CLEVELAND PARISH COUNCIL MEETING** on Monday 7<sup>th</sup> March 2022

- 1. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.
- 2. Apologies of absence were received from District Cllr A Wake, and NY Police.
- 3. No declarations of interest were made.
- 4. The minutes of the meeting held on 24th January 2022 were declared as a true and correct record and signed accordingly by Cllr Frew
- 5 Ongoing issues and the decisions made
- **5.1**The Police were unable to attend but sent a report detailing 1 incident of Anti-Social Behaviour vehicle hit by egg whilst in motion. Officer dispatched but no suspect identified. 1 report of dangerous driving & 1 report of criminal damage but no detail supplied. Fraud/Scams to be aware of text messages offering cheaper deals on gas and electric which contain links to click on which try to obtain bank details. The police advise NOT TO CLICK on these links.
- **5.2**. Noticeboard Mr D Weighell has been advised by Hambleton District Council that in order to erect the noticeboard he would have to complete a course costing approx. £1000. This is unacceptable so another avenue is to be explored. A site visit is to take place to establish if another site is available for the erection of the noticeboard.
- **5.3** Blocked drains- All drains belonging to NYCC are clear. The owner of the field that is causing flooding when it rains on Hill Road is to be contacted by NYCC Highways to ascertain the reason.
- **5.4** The Queens Platinum Jubilee June 2022 Kirkby & Great Broughton Sports Club has not made any plans at this time. Great Broughton PC advise that as many of the school children are not actually residents in either of the villages it does not seem to be viable to provide commemoration mugs. The Parochial Parish Council is to meet on 16th March and any decision made will be supported by the Parish Council financially and with practical help.
- **5.5** HM Land registry (HMLR) parish land ownership survey The PC needs to establish ownership of the greens in the parish. Clerk to action.
- **5.6** Complaint to HDC Cllr Scott to action.
- **5.7** Dromonby Bridge Farm The static caravan has been removed. Cllr Griffiths is to follow up regarding the waste disposal.
- **5.8** Grass cutting 2022 Andrew Liddle Gardenworx is to cut the grass at £45 per cut. AGREED. This service is to include the removal of the grass and trimming the edges. Cllr Tomlinson is to prepare a detailed description of the requirements of the Parish Council. Cllr. Seymour to liaise with Andrew Liddle.
- **5.9** Defibrillator Cllr Frew has obtained new batteries and pads. A First Aid kit was included in the delivery. A guardian is yet to be found.
- **5.10** School House -Wall repair. Zurich is to be contacted for the policy details to establish if any injuries occurred as a result of the stone storage are covered.
