- 1. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.
- 2. Apologies of absence were received from County Cllr H Moorhouse, District Cllr B Griffiths, District Cllr A Wake Cllr M Weighell and NY Police.
- 3. No declarations of interest were made.
- 4. The minutes of the meeting held on 7th March 2022 were declared as a true and correct record and signed accordingly by Cllr Frew
- 5 Ongoing issues and the decisions made
- **5.1**The Police were unable to attend but sent a report detailing that there was no criminal incidents reported. North Yorkshire Police will be in attendance at Stokesley Farmers Market on 21st May 2022 and on the 3rd Saturday of the month after that. - **5.2**. Noticeboard Mr D Weighell is to erect the noticeboard on the green opposite the Black Swan, the exact positioning is to be decided at a later date.
- **5.3** Blocked drains- Mr J Collings of NYCC Highways has ascertained that the flooding beyond Hill View up Hill Road is not the responsibility of the County Council. The PC will continue to monitor the situation.
- **5.4** The Queens Platinum Jubilee June 2022 There is to be a church service on Sunday 5th June followed by refreshments in the Church Hall. The festivities will continue at the Sports Club after that. Cllr. Frew to contact Karl Watson (Sports Club) to offer support.
