MINUTES

KIRKBY IN CLEVELAND PARISH COUNCIL MEETING via Zoom

Attendees: County Cllr H Moorhouse, District Cllr B Griffiths, Cllrs M Frew, T Seymour, R Tomlinson, M Weighell, A Scott, clerk Mrs L Smith. 1. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.

2. Apologies of absence were received from District Cllr AWake and the Police.

3. No declarations of interest were made.

4. The minutes of the meeting held on 8th March 2021 were declared as a true and correct record and signed accordingly by Cllr Frew

5.1 Police Report – The police were unable to attend: - however a report was received. There was 1 incident recorded which was one of fraud. The Police are reminding all residents to be vigilant for scam phone calls in relation to National Insurance Numbers. The calls usually claim that the NI No has been compromised and that a fee is required for a new number. It has been advised that the call should be terminated immediately and 101 contacted. **NEVER** provide personal information over the phone.

5.2 30 mph sign – Cllr Scott has obtained the 30mph signs at a cost of \pounds 21.40. These signs will be placed in position in due course.

5.3 Grit bin – The bin has been positioned near the entrance to the Northumbrian Water Reservoir entrance. Cllr Frew thanked County Cllr Moorhouse for her assistance.

5.4 New noticeboard - The clerk has obtained an estimate for 2 different sizes of noticeboard but is now waiting to ascertain which size would be the most appropriate for the council's needs. When a decision has been reached further estimates will be obtained. 5.5 Website –This is ongoing

5.6 TRO notices for Kirby Bank – Cllrs Frew and Seymour are to liaise to confirm the wording and size of these signs)

5.7 Blocked drains – The drains have been jetted by NYCC Highways but Cllr Weighell advised that they were blocked again, by silt, within a few days. County Cllr Moorhouse is to contact Mr J Collins of Highways. District Cllr Griffiths suggested a site meeting of all parties concerned to ascertain the reason for the constant blockage of the drains around Dromonby Hall and Dromonby Hall Farm.

5.8 Gt. Broughton playpark – There does not appear to be any formal documentation regarding the arrangement of Kirkby Parish Councils's contribution to the upkeep of the playpark. The playpark is to undergo a large refurbishment starting on 14th May at a cost of approx. £17000. As Kirkby PC did not buy the VAS equipment there is an unexpected surplus of funds, the decision was made to offer Gt. Broughton PC a contribution of between £2500-£3000 towards the purchase of new equipment. Cllr Frew is to liaise with the chair of GBPC with regards to KPC future contribution; bearing in mind the precept for KPC is considerably smaller than that of GBPC. Once a mutual decision has been made a written agreement should be drawn up. A request for regular invoices for grass

cutting is to be made.

5.9 Toft Hill Caravan Park – The Park is now open. Everyone who was present during lockdown had a legitimate reason for being there. District Cllr Griffiths is to ascertain the current rules and regulations regarding lengths of stay in caravan parks. The park is still in breach of the planning permission of 2010 and HDC is continuing to investigate.

5.10 Tree Protection Orders – HDC decided that the trees were not in a good condition so a protection order was refused.

5.11 The Annual Parish Meeting is to be held on 24th May 2021 in the Church Hall rather than the Flintoff Room to allow for the necessary distancing for indoor meetings to comply with Covid regulations.
