MINUTES

KIRKBY IN CLEVELAND PARISH COUNCIL MEETING on Monday 24th May 2021

Attendees: County Cllr H Moorhouse, District Cllrs B Griffiths &A Wake, Cllrs M Frew, T Seymour, R Tomlinson, M Weighell, A Scott, clerk Mrs L Smith. 1. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.

2. Apologies of absence were received from the Police.

3. No declarations of interest were made.

4. The minutes of the meeting held on 19th April 2021 were declared as a true and correct record and signed accordingly by Cllr Frew

It was decided that item 11 should take place at this point. The Election of Officers was as follows-:

5.1The Police were unable to attend but sent a report detailing there were no incidents received.

5.2 30 mph sign – These are now in position on the village signs. Cllr Frew thanked Mr R Gill for undertaking the task.

5.3. New noticeboard – It was agreed that the sign should be ordered but the lettering should read KIKBY-IN-CLEVELAND PARISH COUNCIL.

5.4 – Website - Still ongoing.

5.5 – Blocked drains – The drains around the area of Dromonby Hall and Dromonby Hall Farm have been jetted and cleared of gravel/debris and are running freely now . Efforts to lift a manhole cover resulted in it sustaining some damage – it will need to be replaced in due course. The responsibility for the drains on Hill Road needs to be ascertained.

5.6– Gt.Broughton playpark – Many thanks from Mr M O'Neill for the offer of a contribution towards the refurbishment, which is proceeding according to plan.

5.7 –Toft Hill Caravan Park – As yet there has been no retrospective planning application. The situation will continue to be monitored. Cllr. Tomlinson raised the question of the Parish Council's disillusionment that HDC appear to ignore the comments/objections of the Parish Council. Cllr. Tomlinson agreed to draft a letter for approval. District Councillors Griffiths and Wake asked to be copied in to this.

5.8 - Community Speedwatch – There has not been any volunteers. A notice has been put in the June newsletter asking for new volunteers.

5.9 – Gt.Broughton Village Hall Committee representative – Mr John Davies has agreed to continue in this position on behalf of KPC.

5.10 - TRO notices for Kirby Bank – There are 2 sizes: - 550x360 - £16+VAT & 750x650

- \pounds 24+VAT. It was decided that the larger signs be used and Cllr Seymour is to order 3, one for the gate at the top of Hill Road and two (one each side) for the wooden gate halfway up Kirby Bank at the top of the Trod

5.11 – Spring Village Tidy Up Session – The session went well and the PC's thanks are to be in the Church newsletter. Thanks also to Streetscene.

5.12 – YLCA consultation re remote meetings – Not actioned as still within deadline.

6.2 21/00952/FUL- Change of use from agricultural to equestrian and construction of an equestrian barn and riding arena at Westlea, Hill Road. Kirkby in Cleveland, North Yorkshire TS9 7AN – A response has been sent expressing the PC's objections.

6.3 20/01963/FUL - Creation of a new detached dwelling at land north Of Appledore, Kirkby Lane, Kirkby in Cleveland, North Yorkshire – A site visit took place today at 10.00am with the planning committee due to meet on Thursday 27th May. Cllr Frew is to attend to reiterate the objections of the PC
