MINUTES

KIRKBY IN CLEVELAND PARISH COUNCIL MEETING on Monday 13th September 2021

Attendees: Cllrs M Frew, R Tomlinson, M Weighell, A Scott, clerk Mrs L Smith 1. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.

- 2. Apologies of absence were received from, District Cllr A Wake, Cllr T Seymour and NY Police. County Cllr H Moorhouse and District Cllr B Griffiths were delayed.
- 3. No declarations of interest were made.
- 4. The minutes of the meeting held on 13th July 2021 were declared as a true and correct record and signed accordingly by Cllr Frew
- 5.1The Police were unable to attend but sent a report detailing there were no incidents received. Residents are reminded to be vigilant for scam phone calls relating to their National Insurance Numbers. If a call of this nature is received, hang up immediately and report it to the Police by calling 101.
- 5.2. Noticeboard Cllr Scott is to ask Mr D Weighell if he is able to remove the old noticeboard and erect the new one on delivery.
- 5.3 Website Cllr Scott is to thank Thomas Jones for setting up the new website. It was agreed that he will maintain the website for a trial period of 1 year. Agendas, minutes and details (including pictures) of local events to be sent to him for inclusion on the website.
- 5.4 Playpark Great Broughton PC thanked Kirkby PC for its contribution. The clerk is to request that the invoice for the grass cutting be forwarded on a more regular basis and also how frequently GB Parish Council wishes payment to be made.
- 5.5 Community Speed Watch CSW thanked the PC for its participation and stated that the scheme may be restarted at any time.
- 5.6 TRO notices for Kirby Bank The notices are up and there has been a reduction in the number of bikes. Cllr Frew thanked Cllr Seymour for putting the notices up.
- 5.7 Blocked drains The use of outside contractors for drain clearance is to be discontinued. NYCC is to prioritise problem areas and rectify them from in-house contractors.
- 5.8 The Queen's Platinum Jubilee in June 2022 Cllr Tomlinson is to approach the school to ask if the pupils would like to plant oak saplings that she has. As of yet the Sports Club has no plans. The Church has not discussed this yet at a PCC meeting.
- 5.9 HM land registry (HMLR) parish land ownership survey- Cllr Tomlinson is still investigating.
