### KIRKBY IN CLEVELAND PARISH COUNCIL MEETING on Monday 1st November 2021

- 1. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.
- 2. Apologies of absence were received from, District Cllr A Wake, Cllr R Tomlinson and NY Police. County Cllr H Moorhouse and District Cllr B Griffiths were delayed.
- 3. No declarations of interest were made.

- 5.1The Police were unable to attend but sent a report detailing there were no incidents received. However Cllr Seymour had reported 2 incidents of poaching on the 4<sup>th</sup> & 6<sup>th</sup> October. Residents are encouraged to reduce the risks of burglary by using timers for turning lights on, hiding valuables and locking doors. - 5.4 Blocked drains Highways are awaiting funding. Normal drain clearance & jetting will be continued but schedules have not been issued yet. There appears to be a damaged drain where the new entrance has been created 2 fields up from Hill View. The damaged manhole cover has been replaced and the drains jetted along Busby Lane by Dromonby House and Dromonby House Farm. Funding for work to the blocked drains on Hill Road near the crossroads is being sought by Highways.

- 5.6 HM Land registry(HMLR) parish land ownership survey ongoing
