- 1. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.
- 2. Apologies of absence were received from District Cllr A Wake, District Cllr B Griffiths, Cllr A Scott and NY Police.
- 3. No declarations of interest were made.
- 4. The minutes of the meeting held on 13th December 2021 were declared as a true and correct record and signed accordingly by Cllr Frew
- 5 Ongoing issues and the decisions made
- **5.1**The Police were unable to attend but sent a report detailing there were no incidents received.
- **5.2**. Noticeboard —The noticeboard was delivered today. Mr D Weighell is to be contacted to ascertain if he is able to put the noticeboard in place.
- **5.3** Blocked drains- Photographs are required of the drainage problem just beyond the 30mph sign on Hill Road in both wet and dry conditions. Clerk to report the drainage problem at the top of Hill Road to NYCC Highways.
- **5.4** The Queens Platinum Jubilee June 2022 Cllr Frew is to liaise with Great Broughton PC as to the decision of commemorative mugs for the school children. A big lunch/tea was suggested for 5th June. There is to be a special church service on 5th June.
- 5.5 HM Land registry (HMLR) parish land ownership survey ongoing
- **5.6** Complaint to HDC as all the Cllrs were not present it was decided to carry this item to the next meeting
- **5.7** Dromonby Bridge Farm The environmental health officer has spoken with the occupier, not the owner, of the land concerning the burning of waste. The item is to be followed up.
- **5.8** The tree has been pruned by Mr Harry Johnson. It was agreed that Mr Johnson be asked to prune the tree on a regular basis.
- **5.9** Grass cutting 2022 As Mr Heaviside has now retired, Cllr Seymour is to approach Mr Andrew Liddle to request that he take up the duties.
- **5.10** Defibrillator The defibrillator requires new guardianship, batteries and pads. A monthly check is also required and Cllr Frew is to make enquiries of local residents as to volunteers. The defibrillator has to be registered with the British Heart Foundation.
