- 3. The Chairman reminded the Council that there was a possibility for the audio recording of the meeting.
- 4. Apologies of late arrival received from Cllr Scott
- 5. No declarations of interest were made.
- 6. The minutes of the meeting held on 24^{th} April 2023 declared as a true and correct record and signed accordingly by Cllr Frew
- 7 Ongoing issues and the decisions made
- 7.1 Blocked drains portal not yet visited by clerk. Northumbrian Water appears to have done extensive work to the drains near The Grange but no details are available. Work still needed on Busby Lane between Dromonby Hall and Dromonby Hall Farm entrances. Still waiting for funding for repair to drains outside Kirby House.
- 7.2 Government Planning Reform Cllr Passman offered to take part in the YLCA webinar at 6.30pm on 24th May 2023 and update the PC at the next meeting.
- 7.3 Spring Village Tidy Up went well and much was achieved. Cllr Frew thanked everyone who took part. Clerk/RFO undertook risk assessment of the benches all secure and in safe condition, only cosmetic work needed.
- 7.4 Coronation Day Celebrations Cllr Passman informed the PC that the day was an overwhelming success with the residents of the two villages coming together to celebrate the Coronation of King Charles III and to raise funds for local causes.
