When a tractor has a fully loaded trailer the speed of the tractor is reduced. Kirkby is a rural village so tractor activity is a part of village life. After discussion it was agreed that Cllr. Scott would buy some more Slow Down signs for use in the village to reinforce the existing ones. RESOLVED
