- 1. The Chair reminded the Council that there was a possibility for the audio recording of the meeting none were made
- 2. Apologies of absence North Yorkshire Police, Cllr A Scott
- 3. No declarations of interest were made.
- 4. The minutes of the meeting held on 22^{nd} January 2024 declared as a true and correct record and signed accordingly by Cllr Frew.
- 5 Ongoing issues and the decisions made
- 5.1 The police report A report was received from NY Police stating that there had been one crime of violence against a person reported during January and no crimes at all during February. It was reported to the PC that a sheep had been killed and that there had been an incident of poaching, but these were not on the police report. Cllr Passman attended the Police Drop In at the Globe. The "No Cold Calling" signs which he had hoped to obtain were unavailable but are to be forwarded later for distribution to any households which require them.
- 5.2 Mrs C Kerr was in attendance to give the PC an update on the recent change of ownership of the Wainstones Hotel in Great Broughton. It is to remain as a hotel, with more of a community feel for the two villages Gt. Broughton and Kirkby as it is proposed to add a café to the front of the building. Any ideas for any community involvement from residents are welcome.
- 5.3 Tree pruning Cllr Passman is to obtain further quotes for the work.
- 5.4 Code of Conduct/Standing Orders- Code of Conduct is to be placed on the website. As the Standing Orders is a long document it was decided that a link would be placed on the website for anyone wishing to view this document.
- 5.5 Interpretation board the History Society is to proceed with obtaining more information i.e. cost/contractor etc. The parish council will be consulted in due course as to content and positioning.

workshop he attended. Blocked drains been a problem made worse by the amount of rain. The work to be conducted by Highways on Hill Road is for clarification of how/who caused the damage to the drain. Its ultimate repair may be a long drawn out process.
