#### MINUTES OF KIRKBY-IN-CLEVELAND PARISH COUNCIL MEETING ON 17<sup>th</sup> June 2024

**1.** The Chair reminded the Council that there was a possibility for the audio recording of the meeting – none were made

2. Apologies of absence – Cllr T Seymour.

3. No declarations of interest were made.

# 4. The minutes of the meeting held on 20<sup>th</sup> May 2024 declared as a true and correct record and signed accordingly by Cllr Frew.

#### 5 Ongoing issues and the decisions made

5.1 The police report – A report was received from NY Police stating that there had been one incident of auto crime – (Stolen Motor Vehicle) during May.

5.2 Tree Pruning – (i) The pruning of the cherry tree near the church has been completed. It was decided that this tree, together with the one on the green opposite the pub, should be regularly maintained – every2/3 years.
(ii) Grass cutting/sett cleaning – awaiting response.

5.4 Planning Enforcement and Appeals webinar on 22<sup>nd</sup> May - Cllr Frew gave a report. Once an application has been granted and providing the process has been followed correctly then no decision may be overturned. Enforcement is not always easy and if a breach has been ascertained a letter will be sent followed by an enforcement notice. However, the applicant may be invited to submit a retrospective planning application or a lawful development certificate.

5.5 New NALC Micro Councils Network (MCN) It was decided unanimously that the Parish Council does not wish to take part.

5.6 Ivy House – No response from the enforcement officer. No further action is to be taken. The minutes of 18<sup>th</sup> June 2022 were discussed and agreed to be accurate.

5.7 Toft Hill Caravan Park – a letter was sent by Cllr Frew to the planning dept, and an acknowledgment was received.

5.9 Interpretation Board – County Cllr Griffiths confirmed that the

Locality Budget would be able to contribute towards the Boards but not cover the full cost.

One response received from notice in parish newsletter from someone who may be able to get the speed gun working. As car parking is becoming a problem Cllr Passman is to monitor this situation too.
