- 1. The Chair reminded the Council that there was a possibility for the audio recording of the meeting none were made
- 2. Apologies of absence County Cllr Griffiths advised that he would be late
- 3. No declarations of interest were made.
- 4. The minutes of the meeting held on 27<sup>th</sup> January 2025 declared as a true and correct record and signed accordingly by Cllr Frew.
- 5 Ongoing issues and the decisions made
- 5.1 The police report Reports were received from NY Police stating that there were no incidents reported from 1st January 2025 to 28<sup>th</sup> February. However, Cllr Seymour advised the PC that there had been an incident on his land on 3<sup>rd</sup> February involving coursing, and that his wife had been threatened.
